

Did you pay for a credit freeze after the 2015 cyber attack? If so, please fill out this form and send to us.

Important things to know

- You're eligible for this offer if you were affected by the 2015 Anthem cyber attack and you were younger than 18 years old as of January 27, 2015.
- You can use this form if you (or your parent/legal guardian) paid for a credit freeze between February 5, 2015 and the date on the letter that came with this form.
- You can also use this form if you pay for an adult credit freeze within one year of the date on the letter that came with this form.
- We can only pay you back for credit freezes placed with Equifax, Experian or TransUnion. This includes your cost to remove the freeze. If you haven't paid to remove a freeze, we'll pay you now based on removal fees noted in current state credit freeze laws.
- You must send us this form within one year of the date on the letter that came with this form.
- After receiving your reimbursement form, we'll send you a response in about 45 days.

If you didn't place a freeze with all three bureaus, put N/A in the "Date freeze placed" column for each bureau you did not place a freeze. Fill out all of this information.
